#### Late Fees

Monthly fees are due by the 5<sup>th</sup> of each month. A \$30 late payment fee will be charged, if the monthly fee has not been paid by the 6<sup>th</sup> of each month. If the 5<sup>th</sup> falls on a holiday or weekend, you will have until the following day of school to pay any outstanding balance before late fees are assessed. You will be charged an extra \$3.00 per child for every 5 minutes you are late picking up your child from after care.
